- ⑤ This license shall terminate: (a) if any provision of this agreement is violated, or (b) if the selection should not be published by the Newspaper within 1 year; or 70 days from the date of publication of the first chapter.
- ⑥ **The Missouri Press Foundation agrees** to indemnify and defend the Newspaper for any claim or suit that may arise out of publication of the material licensed to the Newspaper under this agreement.

# ADDENDUM TO MISSOURI PRESS NEWSPAPER CONTRACT FOR SERIAL STORIES

## Additional Terms Relating to Rights to Reproduce Materials in Electronic Format

The Newspaper agrees:

1 To pay upon signing the non-refundable amount of \_\_\_\_\_ based upon the newspaper's circulation \_\_\_\_\_ and the following rates:

2 That by acquiring these additional electronic rights, the Newspaper confirms that the materials will be published only on a website which is secure, which is defined as one which is available only to subscribers of said Newspaper (further defined as persons paying a fee to said Newspaper for a print subscription or a web-only subscription) and that said materials will NOT be made generally available on a website which is accessible to the general public for free.

3 That the electronic availability of these materials shall not extend beyond the period of 70 days from the date the materials first are made available for electronic access.

4 That the Newspaper agrees that should it be found in breach of the terms of this agreement in that it has placed the materials on a non-secure website, that it will agree to pay to the Foundation liquidated damages in the sum of twenty times the licensing fee set out in paragraph 1 of the underlying Agreement, inasmuch as actual damages are difficult to ascertain in such matter.
